

WHAT YOU NEED TO KNOW ABOUT CARM: KEY CHANGES FOR COMMERCIAL IMPORTS INTO CANADA

The Canada Border Services Agency (CBSA) Assessment and Revenue Management – or CARM– is a multi-year initiative that is transforming the way the CBSA manages commercial goods being imported into Canada, including collection of duties and taxes.

Who is impacted?

All CBSA trade partners, including: Importers, Customs Brokers, Trade Consultants, Surety Companies, Carriers, Foreign producers/exporters and industry professionals (e.g., lawyers, accountants, shipping agents)

What exactly is CARM?

This is a project launched by the CBSA to simplify and modernize their accounting and data-management systems. The goal is to help organizations involved in commercial trade more easily interact with the CBSA – by replacing existing revenue and cash-management systems, streamlining processes and introducing direct interactive electronic options.

The first phase of CARM – (Release (RLS) 0), involved the Accounts Receivable Ledger (ARL) and was implemented in January 2021. Detailed information on the ARL is available on the <u>CBSA Commercial Payments and Accounts webpage</u>.

The next phase of CARM is being implemented in two stages:

Release (RLS) 1 - May/June 2021

As of May 25, 2021, the new <u>CARM Client Portal (CCP)</u> was launched for use by importers, Customs brokers and trade consultants, who will be required to register and create an account on this site to deal with:

- Delegation of authority to Customs brokers by importers allowing brokers to continue managing their commercial importation activities (e.g., duty and tax assessment with the CBSA)
- Self-management and payment of monthly statement of accounts (SOAs)
- Self-service access to the CBSA Harmonized Tariff Schedule (HTS) classification and duty/tax estimator tools
- Application for and tracking of Customs rulings

Release (RLS) 2 - May/June 2022

Additional CCP features and functionality will include the following:

- All CBSA trade chain partners (TCPs) will have access to the CCP
- **Release Prior to Payment (RPP) Privilege** Importers will be required to post their own financial security (i.e., surety bond or cash deposit) to maintain their RPP privilege
- **The Commercial Accounting Declaration (CAD)** This new digital document will replace the current form B3 (Customs coding form) for the accounting of imported goods with the CBSA
- Electronic submission of entry corrections and adjustments (form B2 will be replaced with CAD version updates)
- New billing cycles and additional payment options
- Business number and CBSA program registration



What are the key changes for commercial importers?

• Canadian Business Number (BN)

New importers will now have to acquire a valid BN and Import-Export (RM) program account number before importing goods into Canada.

Once RLS 2 begins, importers will have to apply for BN and RM numbers directly through the CCP

• CCP Registration

All business with the CBSA will be done through the new CCP. In order to continue their commercial importation activities, importers will have to set up a CCP business account prior to RLS 2 – which will require designation of a Business Account Manager (BAM)

• Delegation of Authority

The BAM must grant this authorization to their third-party service providers (e.g. Customs brokers) via the CCP, enabling them to manage their commercial importation activities. After RLS 2, only importers' delegated customs broker(s) will be able to perform customs entry filing and duty and tax assessment services on their behalf. This delegation is an additional requirement and does not replace the current requirement for a Power of Attorney (POA) or General Agency Agreement (GAA) to authorize a customs broker to act on behalf of an importer.

• **Obtain an RPP Bond.** Commercial importers will be required to post their own financial security (i.e., surety bond or cash deposit) with the CBSA for the release of their goods, prior to accounting and payment of all applicable duties and taxes. Any RPP security paid by a Customs broker will no longer extend to commercial importers who use their services as of RLS 2.
