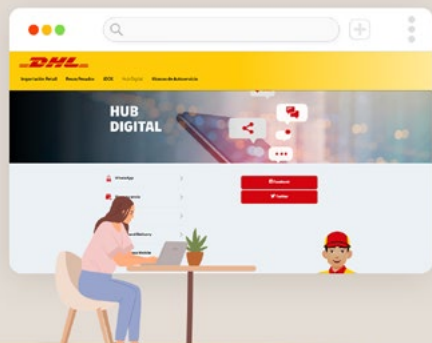

# SENDING YOUR SHIPMENT



## 1. ESTABLISH SHIPMENT WEIGHT


There are two types of weight measurement to be considered before sending your shipment:

### Physical weight

Is the actual weight of your shipment, it is obtained using a scale.

### Volumetric weight

Determine the volumetric weight of your shipment, including its packaging, using the following formula:

$$VW = \frac{\text{Length (cm)} \times \text{Width (cm)} \times \text{Height (cm)}}{5\,000}$$


To know which is the applicable rate, consider the largest weight for its shipment, either physical Or volumetric, according to the result obtained by using the previously described formula.

## 2. 2. IDENTIFY SHIPMENT ORIGIN AND DESTINATION GROUPS

Identify the origin group from the list in this Price and Service Guide, as well as the destination group for your shipment in the corresponding Table. Write them down to locate the rate zones of your shipment.

## 3. FIND THE SHIPMENT RATE ZONE

Cross reference the origin group and the destination group and find the corresponding rate zone according to the list in this rate guide.

Of the established listed on this Price and Service Guide.

For international shipping, locate the country you want to export to/import from and write down the Rate Zone it belongs to.

## 4. PRODUCT SELECTION

Choose the product that best suits your need:

- For international deliveries, refer to the International Product section (P. 4-5).
- For domestic deliveries, refer to the Domestic Product section (P 5).

## 5. MATCH RATE ZONE AND SHIPMENT WEIGHT

Find the appropriate Rate Zone on the Groups and Rate Zones Table in this Service & Rate Guide, and cross-reference it with the weight of your shipment in kilograms -physical or volumetric weight, whichever is greater- to obtain the applicable rate for your shipment.
