

There is no need for local brokers or forwarders to get involved in any part of the process. You are in full control, and able to manage all aspects of your imports in a very simple way.

If you need a faster delivery, our DHL Express 12:00 and DHL Express 9:00 services are available for import as well as our DHL Economy Select Import service for less urgent shipments throughout Europe. You can order an import from another country, to be delivered to your country or any other destination, by using our dedicated electronic shipping solution for imports. You will have one account number, one invoice in a single currency and a fixed price that means you know exactly what you will pay.

#### **DHL Import Medical Express**

Excellent service for medical and health industry. Includes shipment and priority handling of category B biological materials (UN 3373). Medical Express shipments are monitored 24/7 via Global Quality Centers, ensuring all necessary steps are taken.

#### **DHL Import Express Worldwide**

Regular import of spare parts, samples, finished goods or other items, requires comprehensive solutions for you. DHL Express offers a wide range of optional services – from non-standard deliveries and billing options to climate neutral shipping.

#### Delivery Service by 9:00 (10:30 to the USA)

Delivery service by 9:00 (10:30 to the USA) on the next day or on the next possible business day is offered to the majority of business centers in Europe, Africa, Asia and the Americas. DHL Express 9:00 features a money-back guarantee in accordance with DHL Express conditions of cost refund\* and is suitable for pieces up to 30kg and shipments up to 300kg.

#### Delivery Service by 12:00

Delivery service by 12:00 on the next day or on the next possible business day. DHL Express 12:00 offers a money-back guarantee in accordance with DHL Express conditions of cost refund\* and allows for heavier pieces up to 70kg and shipments up to 300kg.

#### Shipment Insurance

Shipment Insurance can be arranged for shipments containing valuable goods, although some restrictions and limitations may content of the shipment. DHL's Shipment Insurance meets the general requirements for loss and damage to goods in transit. Physical loss or damage of goods is covered, subject to specific limitations and exclusions as described in our Terms and Conditions, Section 8\*.

#### **Extended Liability**

If you are sending valuable documents such as passports, visa applications or regulatory certificates you can extend coverage and compensation beyond the DHL standard liability described in our Terms and Conditions\*. In the event of full or partial loss to a document shipment, a fixed amount of 1,700 PLN will be paid regardless of the replacement cost of the document.

#### **GoGreen Plus**

When selected, DHL will reduce (inset) CO2 emissions from air transport through the purchase of Sustainable Aviation Fuel (SAF). SAF can reduce lifecycle carbon emissions by up to 80% compared to traditional jet fuel. GoGreen Plus – Carbon Reduced service, supports Scope 3 emission reductions in alignment with the Science Based Target initiative. The process is audited annually by SGS (Société Générale de Surveillance) to ensure compliance with regulations and standards. Alternative reduction levels and CO2 emission reports are available on contractual basis only. Contact Customer Service or your Sales Representative to find out more.

#### **Verbal Notification**

At shipper's request, a proactive notification service given by Customer Service verbally by phone at an agreed time and to a specific contact person, informing the customer on selected key transport events, incidents, or confirming delivery. Electronic notifications such as emails or text messages generated through shipping tools via self service or arranged by CS through other systems remain free of charge.

#### **Proof of Delivery (POD)**

At sender's request, proof of delivery (a document with scanned receiver's signature) is handed to the Sender. Payable service available at DHL Express Customer Service – International Shipments. Service available for up to 90 days from the date of delivery.

#### **Electronic Proof of Delivery (ePOD)**

Service enabling confirmation of delivery in the form of an electronic document with the scan of recipient's signature. Available for free in the DHL ProView tool and at <a href="maychlexpress.dhl">mydhl.express.dhl</a>. Service available for up to 90 days from the date of delivery.

#### **Residential Address**

Customers shipping to a home or private residence can activate specific delivery options by designating the delivery address as residential. For such shipments, DHL Express will proactively notify the receiver via email or SMS about the shipment's progress. Receivers can then select the most suitable delivery option on the On Demand Delivery website: ondemand.dhl.com.

#### **Duty Tax Paid (DTP)**

At Customer's request, DHL clears the shipment at destination and arranges for the applicable import duties, taxes and regulatory charges to be invoiced to a specified DHL account at origin or third country, rather than the receiver of the shipment being billed at destination.

#### **Saturday Pickup**

At shipper's request, an ad-hoc pickup of a shipment up to 300kg and pieces up to 30kg on a Saturday, at selected postal code areas that have the operational capability, in countries where Saturday is not a normal working day.

#### **Saturday Delivery**

At shipper's request, the destination country will deliver shipments up to 300kg or pieces up to 30kg on a Saturday. The service is available to selected service areas that perform deliveries on Saturdays in addition to the normal operating schedule Monday-Friday i.e. day 6. We offer Saturday delivery services to key cities in more than 70 countries.

#### **Neutral Delivery**

An optional delivery service, allowing the shipper or importer to maintain confidentiality over the declared value of the goods. The delivery facility ensures any shipment documentation that might reveal the value of the goods has been removed by the origin before delivery.

#### **Change of Billing**

This applies when a customer requests a change of defined billing information on an already issued invoice, which will result in a reissuing of the invoice and, in case of an account change, crediting of the old account and debiting of the new.

#### elnvoice

Electronic equivalent of the printed invoice. eInvoice is a multifunctional, reliable and easy-to-use service. It enables email notifications regarding the invoice, as well as viewing and printing waybills for invoiced shipments. eInvoice can be activated and accessed at ebilling.dhl.com/customer/pl/.

#### **Packaging**

All standard packaging delivered ad hoc by courier at the time of collection or as part of our DHL EXPRESS EASY offer is free of charge. Charges apply for all DHL standard packaging items including plastic flyers provided in bulks or stacks (bulk or stack may contain 10, 20, 50 or 100 pieces). By contacting the Customer Service Department, we also offer specialised packaging for controlled positive or negative temperatures. DHL Express specialists will competently advise on the selection of appropriate packaging. More information on: mydhl.express.dhl and https://oso.dhl.com/.

#### **Dedicated Delivery**

On customer request, an immediate or non-routine, once-only delivery of a shipment within a normal working day or a holiday that involves a specific vehicle such as tail lift truck or more than one courier. This definition can include a direct delivery from the Gateway through a dedicated courier.

#### **Hold for Collection**

At shipper request a shipment is held at the default DHL delivery facility at destination for consignee collection, rather than attempt a delivery at the receiver's address. This service is booked through Customs Service or supporting shipping tools. The destination will notify the receiver when and at which facility the shipment is ready to collect. A consignee cell number is mandatory. HFC does not support collections at locations other than the default delivery facility.

#### **Dedicated Pickup**

If your business needs a dedicated vehicle to collect unusual shipments, or a pickup outside normal business hours, we can arrange this for you. At shipper's request, an immediate or nonroutine, once-only pickup of a shipment within a normal working day, weekend or a holiday that may involve a specific vehicle such as tail lift truck or more than one courier. This definition can include a direct connection to the Gateway through a dedicated courier or a pickup after the booking cut-off.

#### **Direct Signature**

Upon customer's request, DHL will obtain signature from the receiver or a representative at the delivery address. In case no one is at the delivery address, DHL will reattempt delivery. DSR shipments cannot be re-routed, dropped in a post box or left with the neighbor. The receiver is authorized to arrange an alternative delivery time at the same delivery address or to collect the shipment from a DHL owned ServicePoint.

#### **Adult Signature**

At Customer's request, DHL will obtain a delivery signature from an adult at the stipulated delivery address. If, for local legislative reasons, proof of the receivers age needs to be verified, DHL may need to request presentation of a valid government-issued personal identification document.

#### **No Signature Required**

On receiver's request, DHL is authorized to leave the shipment in a designated place without proof of delivery signature. The service is selected through ODD either before or after a failed delivery attempt. The delivery courier is given instruction <no signature required>. Selected customers may as well pre-book NSR service as their default delivery option.

#### **Verified Delivery**

On shipper request, DHL will verify the delivery of a shipment to the consignee, through a unique electronic authentication token, in form of a QR code.

#### **Paperless Trade**

Allows the shipper to provide supporting paperwork such as customs invoices electronically when using PLT enabled shipping tools. Country specific restrictions or value limits may apply.

#### **Leave with Neighbor**

Upon receivers request, DHL Express is authorized to deliver when necessary to an address that is adjacent to the receiver's or with a security guard /gatekeeper against a third party signature as proof of delivery. The service is selected through On Demand Delivery (ODD) either before or after a failed delivery attempt. The delivery courier is given instruction <leave with neighbor>.

#### **SURCHARGES**

In order to maintain a consistently high level of service, in specific circumstances DHL Express levies a surcharge for exceptional activities, ensuring that these surcharges are fair for all of our customers.

#### **Fuel Surcharge**

The Fuel surcharge for transport services (TDI, DDI, DDD) will be based on the daily average spot prices for US Gulf Coast (USGC) kerosene-type jet fuel, as reported by the U.S. Department of Energy between 3rd week release of prior month to 3rd week release of actual month. For example, the daily average price for fuel from 18th April to 15th May is used to Determine the applicable surcharge in June. The fuel surcharge applies to transportation charges on all services and to the following surcharges: Saturday Delivery, Saturday Pickup, Elevated Risk, Demand Surcharge, Emergency Situation, Remote Area Delivery, Remote Area Pickup, Dedicated Pickup, Dedicated Delivery, Residential Address, Overweight Piece, Oversize Piece and Non Stackable Pallet. DHL reserves the right to change the fuel surcharge index and table with or without notice. Both the amount and duration of the surcharge will be determined at DHL's sole discretion. The current amount of fuel surcharge is available at mydhl.express.dhl.

#### Category B Biological Materials (UN3373)

Shipments containing Biological Substances Category B (UN3373) packed in compliance with IATA Packing Instruction 650 or genetically modified organisms as per UN3245 are only accepted in combination with DHL Medical Express. Air transportation service only and contractual agreement required. Approved shippers only.

#### **Dry Ice (UN1845)**

A surcharge is applied per shipment when the handling and transportation of shipments involves Dry Ice UN1845 used as a freezing agent for non-dangerous goods such as diagnostic specimens. The surcharge does not include the cost of specialized packaging or the cost of dry ice. Contractual agreement required. Approved shippers only.

#### Lithium-ion Batteries (section II, PI966)

Service and air transport of deliveries containing lithium-ion batteries packed with equipment in accordance with section II of IATA Packaging Instruction PI966 (i.e. the lithium battery installed in the device plus two spare batteries). Deliveries must be packed and labeled in accordance with valid instructions. Accepted from approved shippers only.

#### Lithium-ion Batteries (section II, PI967)

Service and air transport of deliveries containing lithium-ion batteries contained in equipment in accordance with section II of

IATA Packaging Instruction PI967. Deliveries must be packed and labeled in accordance with valid instructions.

#### Lithium-metal Batteries (section II, PI969)

Applicable only for service and air transport of deliveries containing lithium-metal batteries packed with a device, prepared in accordance with the section II of IATA Packaging Instruction (PI969). All deliveries containing lithium-metal batteries must be packed and labelled in accordance with valid IATA instructions. Lithium-metal batteries in bulk (PI968) are not allowed in DHL Express air transport service. Approved shippers only.

#### Lithium-metal Batteries (section II, PI970)

Applicable only for service and air transport of deliveries containing lithium-metal batteries packed with a device, prepared in accordance with the section II of IATA Packaging Instruction (PI970). All deliveries containing lithium-metal batteries must be packed and labelled in accordance with valid IATA instructions.

#### **ID 8000 Consumer Goods**

A surcharge is applied for shipments containing consumer goods such as perfumes, aftershaves, aerosols, nail varnish as covered by the IATA ID8000 section and packed in a form intended for retail sale and shipped to private individuals (B2C). Contractual agreement required. Finished consumer products, these are all articles classified as hazardous materials and belong to: Class 2 - gases (non-toxic aerosols only), Class 3 -flammable liquids classified in Packing Group II and III (perfumes, paints, nail varnishes, removers, etc.), Subclass 6.1 - toxic substances of low toxicity (e-cigarette liquids, etc.) and dangerous goods UN3077, UN3082, UN3175, UN3334 and UN3335 provided they do not present an additional hazard. All consumer goods require a Material Safety Data Sheet to be presented by the sender and preparation for transportation in accordance with IATA DGR Y963 guidelines. At least two completed copies of the Shipper's Declaration for Dangerous Goods are required.

#### **Dangerous Goods**

A surcharge is applied per shipment when the transportation of shipments involves handling substances and commodities classified as fully regulated in accordance with the IATA Dangerous Goods Regulations. This service applies to lithium batteries in Section IB and section II PI965-CAO. Contractual agreement required. Approved shippers only.

#### **Not Restricted Dangerous Goods**

Some dangerous goods are Not Restricted according to a special Provision or Exempt from the IATA Dangerous Goods Regulations, if they are packed and documented accordingly. This is applicable for: Exempt human or animal specimens and Not Restricted as per special provision.

#### SURCHARGES

View charges

#### **ADR Load Exemptions**

A charge is applied per shipment when the handling and transportation of DDI shipments involves substances and commodities exceeding the limits of Limited Quantities set by ADR. DHL Express does not accept: Explosive material of Class 1, Division 2.3 Toxic gas, Division 6.2 infectious substances, Radioactive material of Class 7, High Consequence Dangerous Goods. Approved shippers only.

#### Dangerous Goods in Excepted Quantities (EQ)

This fixed surcharge is applied when the handling and the air and road transportation of shipments involves substances and commodities that are in Excepted Quantities in compliance with IATA Dangerous Goods Regulations. Contractual agreement required. Approved shippers only.

#### Dangerous Goods in Limited Quantities (LQ)

Handling and transportation of shipments containing limited quantities (LQ – Limited Quantities) of dangerous substances and goods (in accordance with ADR 3.4 regulations). Such dangerous goods are restricted to no more than 30kg per piece. This definition does not apply to: dry ice (UN1845), category B biological material (UN3373), dangerous goods in excepted quantities and lithium batteries, for which there are special types of services. This service is available for road transport. Contractual agreement required. Approved shippers only.

#### Non Stackable Pallet

This fixed surcharge is applied to every pallet within a shipment that cannot be stacked, either on request by the shipper, or because of its shape, content or packaging. This surcharge does not apply to pieces below 30kg. This surcharge applies to domestic and international shipments.

#### **Oversized Piece**

This fixed surcharge applies to every piece, including a pallet, with a single dimension in excess of 120cm. Does not apply to pieces already subject to Overweight Piece surcharge.

#### **Overweight Piece**

A fixed surcharge is applied to every piece, including a pallet, that exceeds a scale or volumetric weight of 70kg.

#### **Remote Area Service**

This surcharge applies when a shipment is collected from or delivered to a location that is distant or difficult to serve.

#### **Elevated Risk**

A surcharge is applied when shipping to or importing from a destination country, DHL is operating at elevated risk due to continuous state of war, civil unrest, or continuous threats from

terrorism. Countries affected (subject to change): Afghanistan, Burkina Faso, Iraq, Libya, Mali, Niger, Somalia, Sudan, Syria, Ukraine and Yemen. The currant list of destination countries in scope is published online at <a href="mailto:mydhl.express.dhl">mydhl.express.dhl</a>.

#### **Restricted Destination**

A surcharge applies when shipping to or importing from a destination country that is subject to specific trade restrictions imposed by the UN Security Council or by national legislation such as the European Union or the US Office of Foreign Assets Control (OFAC). Countries affected (subject to change): Central African Republic, Democratic Republic of the Congo, Iran, Iraq, North Korea, Libya, Somalia, Syria and Yemen. Countries subject to national legislation (subject to change): Afghanistan, Belarus, Lebanon, Myanmar, Russia, Zimbabwe. The current list of destination countries in scope is published online at mydhl.express.dhl.

#### **Address Correction**

A fixed surcharge is applied per shipment when the destination address provided by the Shipper is incomplete, outdated or incorrect and DHL is subsequently unable to deliver the shipment. DHL searches and determines the correct address to complete the delivery.

#### **Data Entry**

A surcharge applies if the shipping label is not correctly completed or has not been produced electronically according to DHL standards and therefore requires manual data entry by DHL.

#### **Emergency Situations**

A temporary surcharge, which allows us to cover operating cost increases due to an emergency situation out of DHL's control. Change in market dynamics and air capacity availability is reflected through regular price adjustments. The charge will be applied pro rata based on the chargeable weight (invoiced weight) of a shipment. The customer will receive notification eight days in advance of any additional extra charges, stating the reasons for the charge.

#### **Demand Surcharge**

Demand Surcharges will apply to shipments during a period of high demand. A period of high demand is to be determined by DHL at its own discretion but may include a time of high demand for shipping services or a period with high operational cost. Details regarding the application of Demand Surcharges are set forth at <a href="maychlexpress.dhl">mydhl.express.dhl</a> and will be subject to change upon prior notice. Demand Surcharges apply cumulatively if a shipment and/or individual pieces meet more than one of the specified by DHL criteria. Demand Surcharges apply in addition to the rates and any other applicable charges. The customer will receive notification eight days in advance of any additional extra charges, stating the reasons for the charge.

By making sure that clearance is a smooth and efficient process, we ensure your shipments arrive as quickly as possible, and leave you free to focus on your core business. With our new online platform My Global Trade Services our customers will be able to access International Trade Regulations, Customs Compliance Criteria and landed costs information from one single source, empowering them to reach new markets worldwide.

#### **Non-Routine Entry**

Applies when shipments are subject to non-routine clearance procedures, due to their value, weight and/or commodity as defined by destination Customs Authorities. May also apply in selected countries where DHL is legally obliged to outsource formal clearance entries to a licensed third party broker. DHL will also apply the fee if the customer requests individual entry form in the event that the shipment is eligible for clearance on the consolidated manifest (courier clearance).

#### **Duty Tax Processing: Account Customers**

DHL will accelerate the customs clearance process making prompt payment of duty and tax charges relating to a shipment, while the receiver defers payment until an agreed date.

#### **Duty Tax Processing: Non-Account Customers**

This default service covers any import of a non-document shipment for which DHL has used its own credit line with Customs to advance or guarantee the payment of duties, taxes or regulatory charges on behalf of importers and consumers with whom DHL has no contract.

#### **Clearance Processing**

Applies in selected countries where additional cost is incurred for importing shipments in alignment with government agency requirements.

#### **Clearance Authorization**

Applies when the designated importer has specifically requested to be contacted by DHL before customs clearance is initiated. Charges to be applied against any import where DHL is required to intercept the inbound process and contact an importer where there is no indication on the shipment paperwork or regulatory requirements to do so.

#### **Multiline Entry Clearance**

The clearance of a shipment with multiple commodities or multiple origins for the same commodity. Charges apply when more than 5 lines are recorded on the customs clearance, for example with different commodities or different countries of manufacture. The cost of this service is borne by the importer/exporter, recipient/shipper in accordance with the authorisation given to the DHL Customs Agency.

#### **Bonded Transit**

Bonded Transit applies to both export and import shipments whenever DHL is required to open, manage or report any form of transfer under bond. At customer's request, the transit of a shipment under customs bond. Can arise when delivering ship spares to a foreign ship at anchor, aircraft parts to an aircraft on ground or to a customer's own bonded warehouse. Can apply also when shipments move domestically from/to a Free Trade Zone/Bonded Warehouse.

#### **Post Clearance Modification**

DHL can modify the value, commodity, country of manufacture, or terms of trade information after the import clearance process for goods, to correct or elaborate on what was submitted previously to Customs. Modifications are also necessary when import details such as the VAT number are incorrect on the declaration.

#### **Physical Intervention**

A surcharge applies for shipments being intercepted for physical examination by Customs Authorities. Arrangements for inspections may also include full or partial unloading of a vehicle; the specific marking of prototypes, mutilation of samples or the examination of shipment content.

#### **Bonded Storage**

Storage charges apply when the shipment cannot be released by Customs due to inaccurate/missing documents/information and/or other important reasons beyond DHL's control affecting the time of customs clearance. Charges take effect three calendar days after the shipment arrival date. The day one we take into account, when calculating the time, is the shipment arrival day. The end of the charging period takes place when the operational activities to prepare the goods for delivery have been completed.

#### **Permits and Licenses**

To accelerate import of selected controlled commodities, such as medical devices, pharmaceuticals, computer monitors, laser CD players, cosmetics, eyeglasses, food and food products, DHL is required to file specific information in order to obtain the required import permits or licenses. Service only available in certain countries.

#### **Preferential Origin**

On shipper request, the preparation or provision of a Certificate of Origin or other similar forms by DHL to certify the goods in a particular export shipment have been produced, manufactured or processed in a particular country allowing preferential rates of duty to be claimed at destination. Common examples are EUR1, Form A, ATR1.\*

#### **Broker Notification**

On importer request, DHL will provide the necessary paperwork to the customer's designated broker to perform the import clearance and resume the delivery to the final destination once the clearance is completed. DHL is subsequently not responsible for the timeliness of the submission to customs or for the release of the shipment.

#### **Release to Broker**

On importer request, the release of a DHL shipment to the customers designated customs broker of choice. DHL will transfer the responsibility for a shipment and related customs documentation to the customers nominated broker for clearance and last mile delivery.

#### **Export Declaration**

On the client request, the export declaration required to issue the IE599 message. Applies also in countries where an export declaration is required for shipments containing controlled commodities or exceeding a certain value threshold or weight. Where automated export systems are available to the public, shippers may avoid the charge by submitting the export declaration online. In case of IMP billed shipments DHL will submit the export declaration in order to accelerate the export at origin and pass the charge to the payer's account.

#### **Temporary Import Export**

On customer request DHL facilitates the temporary import/ export of goods by submitting required documents such as an ATA Carnet and adhering to required clearance procedures as specified by Customs.

PREPARING YOUR SHIPMENT: AS EASY AS 1-2-3

#### **Shipment weight**

- Please weigh and measure your shipment.
- If you are sending a large but lightweight shipment, where its volumetric (dimensional) weight exceeds its actual weight, the cost of the shipment is calculated on the space your consignment takes up on the aircraft. This is a standard IATA method. To calculate the volumetric weight of your shipment, simply multiply the length by height by width in centimeters, then divide the total sum by 5,000 for each piece in the shipment. Helpful application calculating volumetric weight is available at mydhl.express.dhl.
- Any piece in the shipment may be re-weighed and/or re-measured by DHL to confirm this calculation.

#### Documentation required: waybill

- All shipments sent with DHL Express need to have a fully completed DHL waybill or label securely attached to each piece. This will enable the successful movement of your shipment through the DHL network. Each waybill or label is individually numbered to allow you to track your shipment from collection through to delivery.
- Your shipment may also need to be accompanied by customs documentation, such as a commercial or proforma invoice, as well as additional paperwork depending on the contents and value of the shipment and the country you are sending to.

#### **Documentation required: invoice**

- A commercial or proforma invoice is required when sending non-document shipments to countries and territories outside your origin country or customs union. This is essentially a declaration containing all the details of a transaction and is used by customs authorities to assess if duties or taxes are payable.
- A commercial invoice is used when goods are part of a commercial transaction or intended for resale.
- A proforma invoice is used when sending goods of no commercial value (for example, when sending samples).

#### **PACKAGING YOUR SHIPMENT**

To ensure that your shipments travel safely and securely through the DHL Express global network, it is important that they are packaged and labeled correctly.

#### Packaging guidelines

- If you are re-using envelopes or boxes, please ensure that old labels and markings are removed
- Securely fix a waybill to each piece in your shipment.
   The waybill can be thought of as the shipment's airline ticket and it will delay delivery if it becomes separated from your shipment
- The barcodes on the waybill are scanned at numerous points during your shipment's journey. Please ensure the barcode is flat and not covered by tape, shrinkwrap or strapping
- Place a waybill on the top or side of each piece in your shipment and please ensure it does not overlap the corners or edges of boxes
- Use adequate protective wrapping for fragile or delicate items and ensure they are packed as far away as possible from the corners of boxes
- To prevent injury to our employees, please pay special attention to the packaging of sharp items. There should not be any possibility of the contents piercing the packaging
- Any individual pieces over 70kg should be placed on a pallet. If you are sending a multi-piece shipment, it is not necessary to place the individual pieces on a pallet unless they exceed 70kg. For example, a shipment comprising four 25kg pieces does not have to be placed on a pallet

#### PROHIBITED AND RESTRICTED COMMODITIES

A variety of laws and regulations, as well as security measures, prevents DHL Express from accepting certain commodities for transport.

#### **Prohibited goods**

- Live animals (Including mammals, reptiles, fish, invertebrates, amphibians insects and birds)
- Human remains or ashes in any form
- Bullion (of any precious metal), loose precious and semiprecious stones, amber
- Cash (current legal tender) (bank notes, currency notes and coins)
- Hunting (animal) trophies, animal parts such as ivory and shark's fin, animal remains, or animal-by-products and derived products not intended for human consumption, prohibited for movement by the CITES Convention and/or local law
