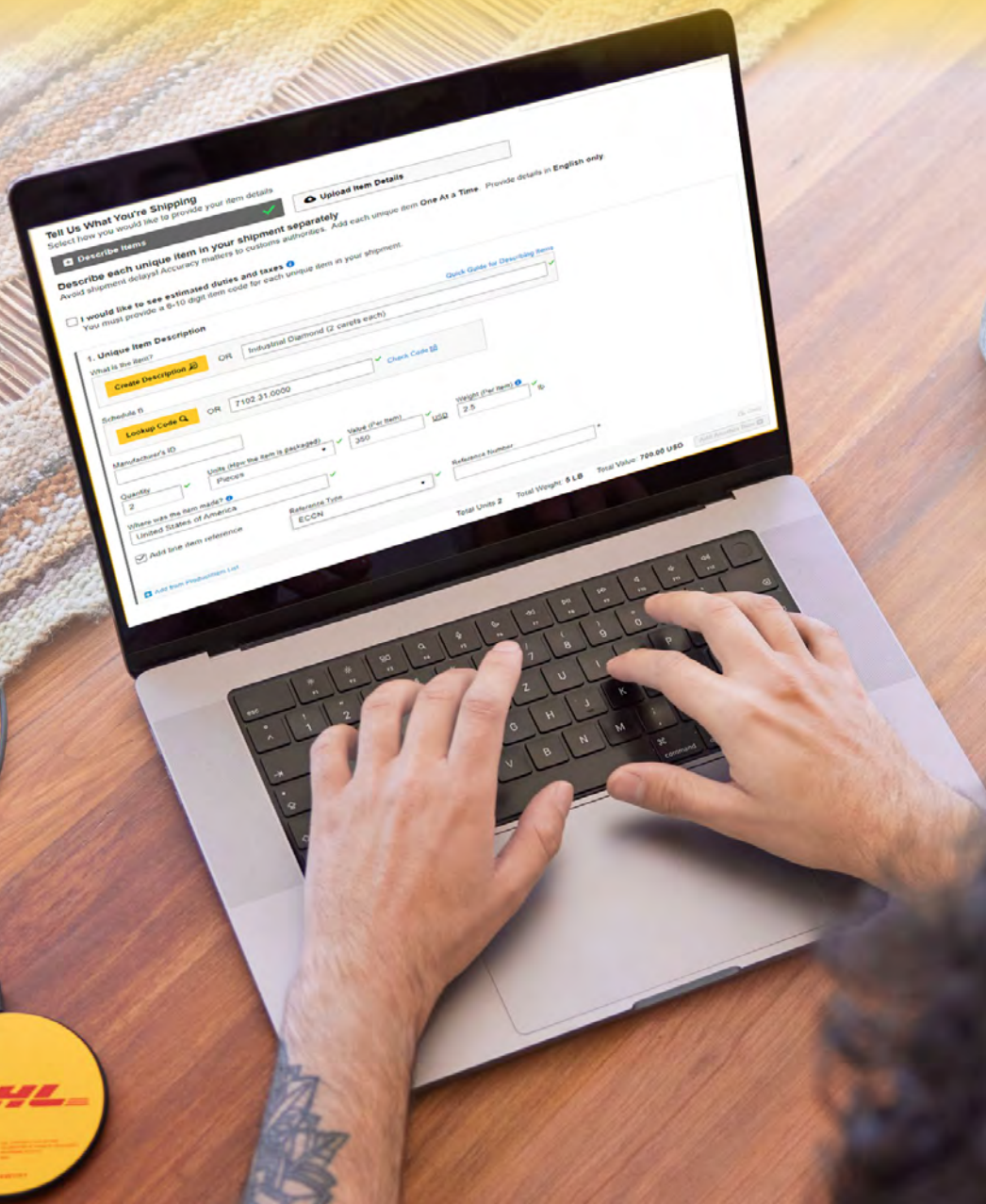

1. CHANGES OF ECCN MANUAL ENTRY

When entering a line item and providing a reference, customers have the option to select an ECCN from the Reference Type field. With this update ECCN will now carry over to the EEI form.

It is important to note that for the ECCN (Export Control Classification Number) to be valid for EEI (Electronic Export Information), it should consist of at least 5 characters.

Tell Us What You're Shipping

Select how you would like to provide your item details

Describe each unique item in your shipment separately

Avoid shipment delays! Accuracy matters to customs authorities. Add each unique item **One At a Time**. Provide details in **English only**.

2. UPLOAD ECCN

Below is an example of a single line entry:

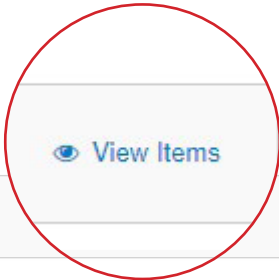

3. EEI CHANGES

In the latest update, line items will no longer be combined if the same Schedule B is used, as shown below. If a customer makes any changes to the Item Description, Schedule B, ECCN, Total Weight, or Total on the EEI form, these changes will be reflected in the invoice generated by MYDHL+. Users will be able to see these changes with a message displayed on each line item, and updated item details will be shown on the commercial invoice.

If you are familiar with the rules and do not want to include the data in the file for an ITN on a line item that does not require filling, you can use the toggles in the include in EEI field to disable the field. This way, the line-item data will not be passed.
